## **ROSTER CHANGE And PLAYER RELEASE NOTIFICATION**

**AGREEMENT:** I, the undersigned, hereby agree to play with the above team during the playing season of **2012** or until I am given my release in writing by said team, and such is recorded in the Athletic Office. I promise to faithfully abide by the rules and regulations as set forth in the Constitution and Bylaws of the San Antonio Senior Softball League and the league of which the above mentioned team is a member.

### **Release, Waiver of Liability and Indemnity Agreement**

1. Release and Waiver of Liability: I recognize that playing softball exposes me to the risk of injury, and failure to use protective gear exposes me to a greater risk of injury, nevertheless, I hereby agree to assume all risks, and in consideration of being allowed to participate in the League and play in its games, I hereby forever release, waive, discharge from all liability for any and all loss or damage, and any claim or damages resulting there from, for any injury to my person or property, whether caused by negligence, breach of contract, wrongful conduct or otherwise. and agree not to sue the following: the San Antonio Seniors Softball League (SASSL), its officers and directors; the manager and sponsor of the individual team of which I am a member; all managers of this league; the City of San Antonio, its personnel, and all Parks and Recreation departments and other entities owning, operating, and maintaining softball fields and other facilities on which league and league-sanctioned tournament games are held.
2. Indemnity Agreement: I also agree to indemnify and hold harmless each of them from any loss, liability, damage or cost they may incur as a result of my participation in the League or its games or other activities.
3. I hereby agree to read and abide by the Rules and Regulations as set forth in the Bylaws of the San Antonio Seniors Softball League.
4. This Release, Waiver of Liability and Indemnity Agreement is in full force and effect unless and until revoked by me in writing and filed with the San Antonio Seniors Softball League through its duly authorized officials.

### **Code of Ethics**

**SSUSA Code of Ethics contained in the official SSUSA rule book will be expanded as follows for SASSL:**

1. A sense of camaraderie and sportsmanship will prevail. Use of foul, abusive, or vulgar language will not be tolerated and could result in ejection.
2. A player who intentionally injures, or attempts to injure an opposing player will be ejected and subject to suspension from the league. This includes a base runner intentionally running into a defensive player.
3. Any player, manager, or other person connected with SASSL who is (a) involved in a physical fight or shoving match with another player, manager, umpire, SASSL officers or commissioners, spectator or other person, or (b) who exhibits any act that is intended to injure any such person or (c) who displays a verbal or abusive attack toward any such, shall, after notice and an opportunity to be heard, be subject to suspension of one game, multiple games, or of one or more years depending on the severity of the violation. The penalty will be determined by the Infractions Panel. This rule applies at any SASSL sponsored event.
